1.	Non-refundable entry fee of \$150.00, in the form of a check or money order payable to the Maryland Community Theater Festival Association or MCTFA.	
2.	Proof of the organization's membership in AACT and MCTFA or a payment of a surcharge of \$55.00.	
3a.	Proof of permission from the leasing agent and/or author to perform the chosen play as it will be performed, including permission for cuts, if any, and proof of payment of royalty fees for the festival performance.	
3b.	Proof of permission and proof of payment for music royalty fees for the festival performance.	
4.	<b>Four</b> copies of the play as it is to be performed. For published plays, Xerox copies are NOT acceptable.	
5.	<b>Publicity photos</b> as described – should be submitted with program by <b>December 11, 2010</b> , so they can be used for advance publicity.
